Brent also designed Google's state-of-the art, in-house trading floor and is the head of the investment team. He runs the team that makes Google's Green Energy investments of over a billion dollars. He joined Google early in 2007 after 14 years at Microsoft. His most recent role there was as Corporate Vice President and Divisional CFO for Microsoft's Platforms and Services Division, which encompassed the Windows, Server and MSN business groups. He was also Microsoft's Treasurer from 2000-2004. Brent received numerous awards and commendations for his leadership at Microsoft, including a 2001 and 2003 Alexander Hamilton award for Overall Treasury Excellence. Previously, Brent worked at Walt Disney, with financial responsibility for Walt Disney Records, and in various treasury and financial capacities at Procter & Gamble. Aside from his many other memberships and advisory roles, Brent served on Washington State's Governor's Council of Economic Advisors from 2001-2006. Brent received a BS in business administration from the University of North Carolina at Chapel Hill and an MBA in finance from UNC Kenan-Flagler Business School. Brent is also a CPA. He was honored with the Distinguished MBA Alumni Award from Kenan Flagler in 2004 and cited as a top alumnus in the Wall Street Journal and Princeton Review. In June 2012, for the fourth time, he was named one of the "100 Most Influential People in Finance" by Treasury and Risk Magazine. Under his leadership, Google Treasury was also awarded the 2010 Adam Smith award for Overall Excellence and the 2012 Alexander Hamilton award for Overall Treasury Excellence.
